MESSAGE FROM THE CHAIR Cont'd





Member Spotlight

AMAR RAVAL

Firm/Company: Partner Berg Plummer Johnson & Raval, LLP Practice area(s): I represent individuals in ERISA, bad faith insurance, personal injury, and business litigation matters.

Hometown: I was born in London, Ontario, but I moved to Houston when I was 4. H-town all the way!

Undergrad education: I graduated with a double major in History and Political Science from Houston Baptist University in 2000.

Law school education: I graduated from Loyola Law School in Los Angeles in 2003. Although I no longer live in LA, I am still very close with a number of my law school friends.

Describe a Career Highlight: getting to argue at the 5th Circuit Court of Appeals in February 2017. The issue was the standard of review applicable in ERISA cases, and I had to try to convince the Court that Texas law changed 26 years of 5th Circuit jurisprudence. It was also my first ever argument to any appellate court. Since I consider myself a trial lawyer, I was not used to arguing before a panel of judges. I was very nervous the night before, but it all came together once I stood at the lectern. The Court wrote a "special concurrence" requesting that the 5th Circuit reevaluate its caselaw, and the Court recently agreed to en banc review. The experience has given me an exciting opportunity to be a small part of a potential change in the law. Involvement with Community Activities and Professional Organizations: 1 am the outgoing President of SABA Houston, having previously served as Secretary, Treasurer, and President Elect. I've cherished my time with SABA, having met so many people locally and nationally through the organization. Many of them are now close friends. I am also a member of the Houston Trial Lawyers Association, Houston Young Lawyers Association, Houston Bar Association, State Bar College, and a Fellow of the Texas Bar Foundation. In the community, I served on the Bellaire Board of Adjustment from 2013-2017. In the last year, I also started teaching 10th graders at my Sunday school, Chinmaya Mission Houston. Teaching has given me a whole new appreciation of both the Bhagwad Gita and learning to connect with a new generation.

Thinking Globally, Running Locally

I want to talk to you about the November 2016 election. No, not *that* race. About my campaign for City Council in Sunset Valley, Texas (spoiler alert - I won!). While some aspects of my race are unique to our city, I'd like to share some lessons I learned in the hope it will encourage more APIS members to serve others through elected office.

Pick the right race

Sunset Valley is a small, rural-feel city surrounded by the City of Austin. We have a small residential population and a large commercial base, with many of the same challenges as a larger metro area. Our city council consists of volunteers, and residents place a premium on electing members who are interested in living and serving in the city -- this is not seen as a springboard to a higher, partisan office. Not only was this race the right "size" for me, it allows me to work on issues directly impacting my local community. That may not be everyone's cup of tea, so be sure to aim for a position that allows you to work on issues that matter to you, not just a title.

Lay the groundwork

Next, educate yourself on what experiences are expected for a successful candidate. In my case, I was already on our city's public safety and budget committees, so I was familiar with the "ins and outs" of our city's budget and hot-button issues. I also had served on a non-profit board and had a strong relationship with our local elementary school as a parent and volunteer. Of course, I had done these things because I believed in them - not to pad my resume - but they helped make the case as to why I was running during my campaign. The point is: you are running on the record you build long before you declare your candidacy, so don't wait to get started.

Don't be afraid to ask for help!

Running a successful campaign takes time (and money) - there's no way around it. Being somewhat of an introvert, I was thankful my race did not require many campaign events (fundraisers, meetings with local groups/clubs, etc.), though our city's culture also placed a higher worth on word-of-mouth and in-person meetings than printed materials or social media (more door-to-door visits, less Facebook posts). All of this takes time away from your family, your practice, and other interests - so be realistic on how much time you can commit and make sure your well-wishers are along for the ride. And for larger races, it is important to have the right team in place (campaign manager, treasurer, etc.) - you just can't do it all yourself.

Ultimately, Sunset Valley residents elected me in a three-way race. With my friend Sean Hassan's victory in a local community college district race, it was the first time two South Asians won contested races in Central Texas (Sean's victory was a much larger race that required much more campaign effort). Hopefully each of these new wins, combined with the electoral victories of established state representatives like Gene Wu and Hubert Vo, district judges like Ravi K. Sandill (Harris Co.) and Todd Wong (Travis Co.), and others in local races across the state, will help ease the path for members of our community who are interested in running in the future.



Ketan Kharod is the founder of the Kharod Law Firm, which represents whistleblowers and people injured by negligence or corporate misconduct, and serves as "of counsel" to Waters & Kraus, a national plaintiff's litigation firm. He is a proud alumnus of the UT School of Law and Georgetown University's School of Public Policy. Ketan is a past board president of the Asian Family Support Services of Austin (AFSSA), which assists individuals and families affected by domestic violence, sexual assault, and trafficking, and has assisted on pro bono matters for AFSSA and Volunteer Legal Services.
